The fiscal year of the Credit Union shall be the same as the calendar year.

FOURTH

The initial share accounts of the credit union shall have a par value as specified in the bylaws, of which not less than seventy (7) shares have been subscribed.

FIFTH

The credit union will not commence business until it has received for the issuance of its shares or deposits cash consideration of at least \$1,000; achieved a membership of at least 100 persons, all of whom shall meet the requirements for membership; and has fulfilled all agreements and conditions related to approval of an application for incorporation and issuance of a certificate of incorporation; and has so notified the Credit Union Department, State of Texas.

SIXTH

Members of the Credit Union shall	be shareholders therein and shall possess the
following definable community of interest:

SEVENTH

The corporation shall exist and be in force perpetually or until the charter is cancelled by the Credit Union Commissioner

EIGHTH

The first board of directors of such corporation shall be _____ in number, all of whom must be charter members and each of which affirms that as a director (s)he will diligently and honestly perform his/her duties in administering the affairs of the credit union, that while being a director (s)he may delegate to others the performance of those duties, (s)he is not relieve from his/her responsibilities for the performance of those duties, and that (s)he will not knowingly violate or willingly permit to be violated any law or rule applicable to the credit union.
